□ Report Your Injury

Be sure to report your injury to your employer in writing as soon as practicable after the injury. You should include your name, address, the cause of the injury, the date and place where the injury occurred.

☐ First Certificate of Capacity Seek medical treatment as soon as practicable for your workplace injury. Please make sure you request a First Certificate of Capacity
from your medical treatment provider.
☐ Workers Compensation Claim Form 2B. Submit it to your employer together with the First Certificate of Capacity. You can deliver the documents to your employer in person or send it to their normal place of business by registered letter.
Remind Your Employer Your employer has 5 working days to complete the claim form and submit it to thier workers compensation insurer. Please remind them at day 5. Don't let your employer delay your workers compensation claim.

☐ Checking With Insurer

The workers compensation insurer has 14 days after claim documents are submitted to make a determination on liability. They must advise the employer and the injured worker in writing if the liability for the claim is accepted, disputed or undecided.

- Accepted you may start receiving compensation entitlements
- Disputed the insurer / employer doesnt accept your claim
- Unable to make decision regarding liability the insurer / employer doesnt accept your claim but doesnt dispute it usually more time is needed to make a decision.

In reality, insurers receive an overwhelming amout of claims every day. It is a good practice to follow up with your employer's workers compensation insurer to make sure your claim is not overlooked!

^{*} If your claim is accepted. it is a good idea to consult a workers compensation lawyer to make sure the correct entitlement is paid in full and on time.

^{**} If your claim is disputed or undecided you can seek a determination of liability through WorkCover WA. It is also a good idea to consult a workers compensation lawyer before lodging a conciliation application with WorkCover WA.
